Matters arising from the minutes

- 1) Apologies from; F Evans, R Woodward
- 2) Last minutes signing; The last minutes were signed by CN
- 3) Declaration of interest; There was none recorded
- 4) Election of the Chairman and Vice Chairman; S Molyneux was elected as Chairman by all attendees and by email from those not attending. Colin Newman has stepped down.

- 5) Audit results; An internal Audit was carried out by GAPTC nominated auditor on the 3/5/2018 and APC was given approval.
 - (A) Annual Governance; This was signed and approved by the Chairman SM and Council on the 15/5/2018.
 - (B) Annual Accounting Statement; This was signed and approved by the Chairman S M and the Council on the 15/5/2018.
 - (C) The Notice of Public Rights; This was set for the dates; Monday 4/June/2018 to Friday 13/July/2018
 - (D) The Audit results for PKF Littlejohn LLP was submitted by post on the 16/5/2018 and is asking for Exemption under the 25k income or expenditure rule. We will await the decision from them in due course.
- 6) AUCA BT Phone Box; It was agreed that SM and DC would approach AUCA to discuss further what was to be done.
- 7) Road Safety A48 through the village; DC presented a survey draft to go out to the Parish to check the level of support. A few amendments were made which DC will action.
