## Matters arising from the minutes:

## Chapel Hill / Church road /Aylburton to Alvington footpath

Some remedial work has at last been completed on the Aylburton to Alvington footpath but all other matters remain outstanding. K.B. has written once again to Jenny Wilks of Glos. Highways to complain about the lack of progress. A reply is awaited.

#### Millbrook seating

M.B. had approached Tudor Carpentry to request that they make a seat which Mr John Mills will pay for & provide a fitting epitaph as a memorial to his parents.

A.J. asked that the old seat be removed as soon as possible as it is proving irresistible to local vandals!

# **Orchard Close parking problems**

Although it was hoped that Brian Watkins of Glos. Highways would attend the meeting to discuss all relevant issues he failed to appear. The PCSO's in attendance reiterated the need for Highways to conduct its own assessment of this matter as the police have very few powers in relation to traffic calming measures etc.

## **Bus Services**

K.B. reported that a letter had been received stating that the local bus service was likely to be further reduced in the near future but that as yet no firm details were available.

#### Alternative Insurance providers

Following the clerk's failed attempts to find a more competitive quote for the annual insurance cover it was agreed to renew with Zurich once again. C.N. suggested that the amount was in fact very reasonable given the level of cover provided.

# **New Business**

### **Funds Transfer**

It was agreed to transfer £2000 from the deposit to the Current account to meet immediate expenses.

## Lydney town Council / Cemetery

It was decided to postpone the payment of the contribution to the upkeep of the cemetery until the next meeting.

#### Church yard shed

John Court of Stockwell Lane had contacted the clerk to request that something be done about the shed at St Mary's church. This is in some disrepair & as far as we know is no longer used. M.B. & A.J. will do a site visit to assess the situation.

Furthermore there is still some concern as to the tree near the Church in terms of its safety. A.J. offered to ask a friend of his to examine the tree & suggest what needs to be done.

## Allotments

The allotments on Kear's Moor will be assessed by L.C. & C.N. as part of their Leisure & Amenities Portfolio remit. It is hoped that by instigating a thorough tidy up of the area further allotments may be formed

The council will also consider issuing allotment holders with agreements regulating the use of the land, length of tenancy etc.

# **Parish Patch**

It has once again been suggested that this land should be rented to a resident of Aylburton rather than (as is currently the case), someone from outside the village. However K.B. stressed that this may be difficult to achieve as the present tenant has occupied the site for many years. An appointment with a local solicitor will be made to ascertain the legal position of all parties.

## Milling Crescent path

It had been brought to the attention of the clerk that the path linking Milling Crescent & Millbrook Green is being rendered dangerous to use by the profusion of overhanging brambles. K.B. will write to the resident concerned asking that he remedy the situation promptly.

## Stockwell Lane speed signs

C.N. asked that the Council look into the matter of erecting signs advising of the speed limit down Stockwell Lane. K.B. will contact Glos. Highways to request that this be considered.

## **GAPTC** training course

Lorna Coates will attend the next available "Being a Good Councillor" course run by GAPTC. K.B. to book this.
